### **Indemnity Payment Briefing and Extension of Winter Indemnity**

### **IR35 Rules Changes and Potential Impact for Locum GPs**

It is important that all GP practices are aware of changes to IR35 rules that take effect on 6 April. They relate to paying workers who provide services via intermediaries (for example, although not restricted to, workers' limited companies). Please read this [briefing](#) with further details.

### **PCSE & Pension Contributions for Year End Accounts**

There is a national issue with regard to pensions and year end accounts. We have escalated this but as it is a national issue it is unlikely to get a quick response or local resolution. Our understanding is that practices should use the current estimate for yearend accounts then reconciliations will be done in April/May. PCSE will be in touch with the individual practices to notify them of the amounts beforehand. We will keep you updated if we hear anything further.

### **Return to Practice**

NHS England have launched a new [website](#) and [brochure](#) to help promote the return to practice programme. The site provides information about the Induction & Refresher scheme for those looking at the possibility of returning to work in the NHS as a GP.

The BMA has been working with NHS England and Health Education England to improve the Induction & Refresher Scheme to make the process less onerous and to increase the number of doctors signing up. Alongside the new website and promotional resources, NHS England will be running a series of adverts to help raise awareness.

### **Principles of Releasing Electronic Medical Information for Insurance Under the Access to Medical Records Act 1998**

In January 2017, the Association of British Insurers published a set of high level principles on requesting and obtaining medical information electronically from GPs. The principles were developed with input from the BMA and the ICO. Compliance with these principles will ensure that the release of electronic medical information for insurance purposes will be in line, or be a higher data protection standard, than the current paper-based system.

### **NHS GP Health Service**

The NHS GP Health Service is a new confidential NHS service for GPs and GP trainees in England. It has been launched as part of the GP Forward View programme of commitments. It will run in parallel to primary care performer occupational health services commissioned by CCG (clinical commissioning groups) under NHS England's national service specification.

Launched on 31 January 2017, The NHS GP Health Service can help with issues relating to a mental health concern, including stress or depression, or an addiction problem, where these might affect a GP's work. Operating on a self-referral basis, it is provided by health professionals specialising in mental health support to doctors and is available in various locations across England.

### **NHS Property Service, 'Heads of Terms', Debt Recovery Letters and Ongoing Issues**

NHS property services or their agents (which include Montagu Evans LLP) are writing to practices, who occupy their premises without a formal lease, with a set of draft 'heads of terms' to start the process of formalising a lease. It is essential that you seek legal advice before agreeing to any terms, as they will need to be moulded to suit your practice's specific needs. The good news is that, until November 2017, NHS England has agreed to contribute towards practices' legal costs – among other commitments.

Additionally, NHSPS have informed GPC that any debt recovery letters were sent out in error by SBS and that practices should ignore these letters. NHSPS sent GPC the below statement:

'Like many in the NHS, NHS Property Services uses NHS SBS services to support our administrative functions. NHS SBS have previously assisted us with contacting customers in relation to outstanding bills, however we ceased using SBS for this activity in June 2016.

We are aware of around 200 letters sent by SBS to our customers due to a computer error during January and February of this year. These letters should not have been sent. We are engaging with SBS to ensure this is not repeated and from June 2017, NHSPS will no longer use SBS to support our administrative functions when these services will move in-house.'

This is clearly an unacceptable way for an NHS organisation to behave and we continue to emphasise the severe distress this is causing practices. NHS property services have committed to get back to GPC with their plan to provide practices with schedules of charges that are reasonable and sensible so this problem can be resolved.
